ELIGIBILITY GUIDELINES

The PNE is currently accepting requests from **registered non-profit charities located in the Lower Mainland** that would like to receive a donation of tickets for the children they serve who have economic, physical, emotional, or cognitive challenges.

INELIGIBLE REQUESTS

Due to the high number of donation requests we receive, the following requests are ineligible:

- Requests from organizations that are NOT registered non-profit charities.
- Requests from registered non-profit charities located outside the Lower Mainland **or** that do not serve children who have economic, physical, emotional, or cognitive challenges. (Under 19 years of age)

TICKET DONATION ALLOCATION PROCESS

Recipient charities are selected through a random draw until a pre-determined allotment of tickets have all been allocated; **submitting a request does not guarantee that tickets will be donated.**

TICKET INFORMATION

On the ticket request form please select the event you wish to receive tickets for.

Playland One-Day Admission Pass – May 5 to September 16, 2018

Each pass includes admission to Playland and access to over 30 rides and attractions on any one day during the Playland regular season; see www.pne.ca for dates and hours (**excluding when the Fair at the PNE is running from August 18 – September 3, 2018**).

Parking and special attractions are not included. Children aged three and under receive complimentary admission to Playland (Please see www.pne.ca for details). Passes used by a guest with a disability permit one accompanying attendant complimentary entry. For other information on services offered to guests with disabilities and to guests with an Access to Entertainment card, please visit Playland Guest Services or contact a Guest Services representative at 604-252-3620.

Fair Gate Admission Passes (Tues-Thurs) – August 18 to September 3, 2018 (closed Mondays August 20 & 27)

Each pass includes admission to the Fair at the PNE on any one Tuesday, Wednesday, or Thursday between August 18 to September 3, 2018. See www.pne.ca for dates and hours. Parking, rides, and special attractions are not included.

Children 13 and under receive complimentary gate admission to the Fair; if a pass is used by a guest with a disability an accompanying attendant will also be permitted complimentary entry.

Fright Nights Passes* – mid-October to late October 2018

Includes admission to haunted attractions and Playland rides, see www.frightnights.ca for dates and hours. Parking and special attractions are not included. Pass details will be determined in September 2018.

*Warning: Not recommended for ages 12 & under, Seniors 65+, people with sensitivity to strobe lighting, people with high blood pressure, or pregnant persons. *NOTE: Only for charities who support youth from 13 yrs. to 18 yrs.*

SUBMISSION DEADLINE

All applications must be emailed to KCskids@pne.ca. Submissions will be accepted between **January 15 to March 30, 2018**.

APPLICATION CONFIRMATION & PROCESSING

All submitted requests will be reviewed promptly after the deadline, and all charities will be notified of the status of their request at the earliest opportunity by a representative of the PNE's Community Relations Department.
