The PNE is happy to invite its immediate neighbours to a night of summer fun at Playland! Each household within our boundaries will receive complimentary Playland admission and rides for a maximum of four guests. Children 3 years and under are welcome and do not count toward the four guest maximum.

Evening of the event, Thursday, June 27, 5:30–7:30pm
at Playland main entrance (off Hastings Street)

We recommend picking up your tickets before the Neighbourhood Party. All guests must enter the gate together.

Additional discounted tickets for the party can be purchased for \$27 each at the Playland ticket booth on the day of the event (ID must be brought to show that additional family lives within neighbourhood boundaries). Maximum of two additional tickets per household.

Special attractions, food, beverages, and games are available for purchase.

This is a private event. No Seasons Passes or other Playland tickets will be accepted. Tickets are non-transferable and not for resale.

COMMUNITY PROGRAMS

The PNE is dedicated to working with local resources to mitigate any impacts from events held on-site.

Some of the ways that the PNE tries to alleviate impacts to the community during the PNE Fair include:



PNE BIKE PATROL

To keep our area safe, PNE security staff rove throughout the neighbourhood on bikes to ensure safety in the community.



PNE CLEANUP CREW

Out in the immediate neighbourhood to help keep the community clean.



FAIR TIME PARKING RESTRICTIONS

During the PNE Fair, car and foot traffic increases, and the PNE will once again be working with the City of Vancouver to have Temporary Resident Parking Only (TRPO) signs installed within the local area. These signs go up the week prior to the Fair. The PNE encourages all guests to take transit, car pool, bike, or walk to the Fair if possible. The City of Vancouver will be patrolling the PNE area throughout the Fair looking for bylaw infractions of backyard parking and non-residential street parking for those with Temporary Resident Parking Only (TRPO) and Resident Permit Parking (RPP). If you have any questions about the parking bylaws please contact the Parking Management Branch by dialing 3-1-1.

BACKYARD PARKING

The City of Vancouver allows neighbours to sell parking spaces in their backyard. More information can be found on their website: www.vancouver.ca/streets-transportation/parking-near-hastings-park.aspx

Help your neighbours stay safe. Gently remind them that the City of Vancouver does not allow patrons to:

- Block traffic
- Put signs on property
- Call out to drivers while on the street or sidewalk
- Wave signs on the street, sidewalk, or on property



SOUND MITIGATION

PNE staff are in the neighbourhood during music events to measure dB levels at various points of the surrounding community throughout each event. This year, the PNE is testing a new sound system in the Amphitheatre to help minimize sound impact to the surrounding community. It is important to note that the sound bylaw does not stipulate that there be “no” sound, it stipulates the level of sound that cannot be exceeded. Therefore, because sound can be heard in the surrounding neighbourhood does not mean the PNE is exceeding the bylaw. Unfortunately sound can be within the bylaw limits, and still be clearly heard.

Bylaw 6555 states: No person shall in an activity zone or an event zone make, cause or permit to be made or caused, continuous sound the sound level of which:

- (a) during the daytime exceeds a rating of 70dB on an approved sound meter when received at a point of reception within an activity zone or an intermediate zone, or 60 on an approved sound meter when received at a point of reception within a quiet zone.
- (b) “continuous sound” means any sound occurring for a duration of more than three minutes, or occurring continually, sporadically or erratically but totaling more than three minutes in any 15 minute period of time.
